ORDER:

In the reference (1) read above, the University has forwarded the proposal to the UGC for grant of Autonomous Status to Jyothishmathi Institute of Technology & Science, Karimnagar, Telangana affiliated to JNT University Hyderabad, Kukatpally, Hyderabad.

In the reference (2) read above, the UGC has conferred Autonomous Status to Jyothishmathi Institute of Technology & Science, Karimnagar, Telangana affiliated to JNT University Hyderabad, Kukatpally, Hyderabad, for a period of Ten (10) Years from the Academic Year 2022-23 to 2031-32 as per provisions of Clause 3.13 and Clause 6.4 (i) of UGC Regulations 2018 and requested the University to issue conferment orders as per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations 2018 for Autonomous Colleges and subsequent regulations issued from time to time by the University.

Also, the UGC has stated that the autonomy granted colleges shall abide by all the provisions of the UGC Regulations for Autonomous Colleges. The college shall apply, in the prescribed format to the UGC, for extension of autonomous status six months prior to the expiry of the autonomous cycle.
